Sample Bequest Language

The provision in your will or revocable living trust providing for a gift to Lebanon Valley College should reflect your own unique circumstances and charitable objectives. We hope these samples will be helpful to you and your attorney.

Unrestricted Gift:

If at any time in the judgment of the College it is impossible or impracticable to carry out the purpose I have designated, the College shall determine an alternative purpose as near as possible to the designated purpose."

Gift from Investment or Retirement Accounts:

You may choose to designate Lebanon Valley College as beneficiary of all or part of your investment account or retirement account. The form may ask for LVC's tax identification number, which is 23-1352354, address (located below), and/or institutional charter date which is February 23, 1866.
